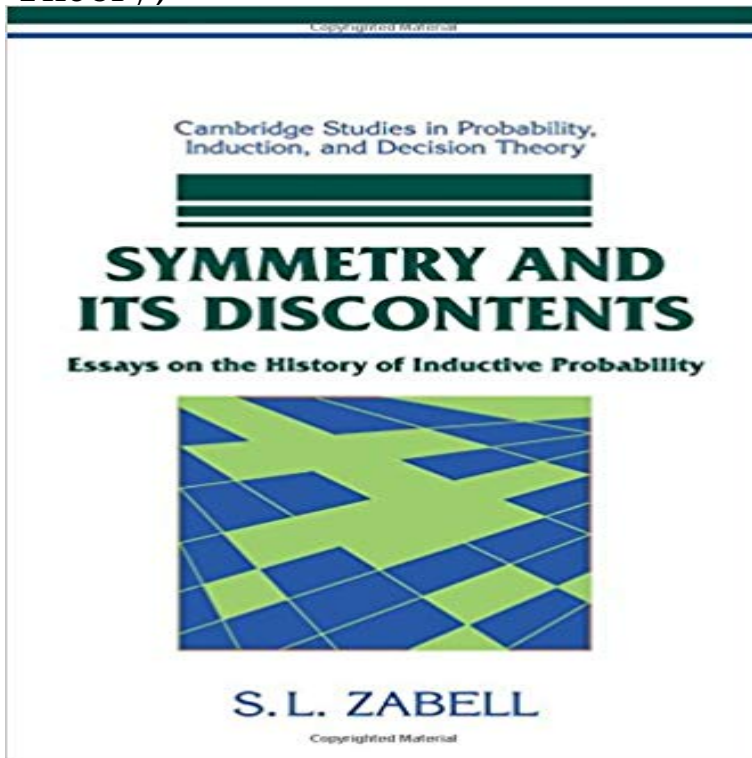


Symmetry and its Discontents: Essays on the History of Inductive Probability (Cambridge Studies in Probability, Induction and Decision Theory)
