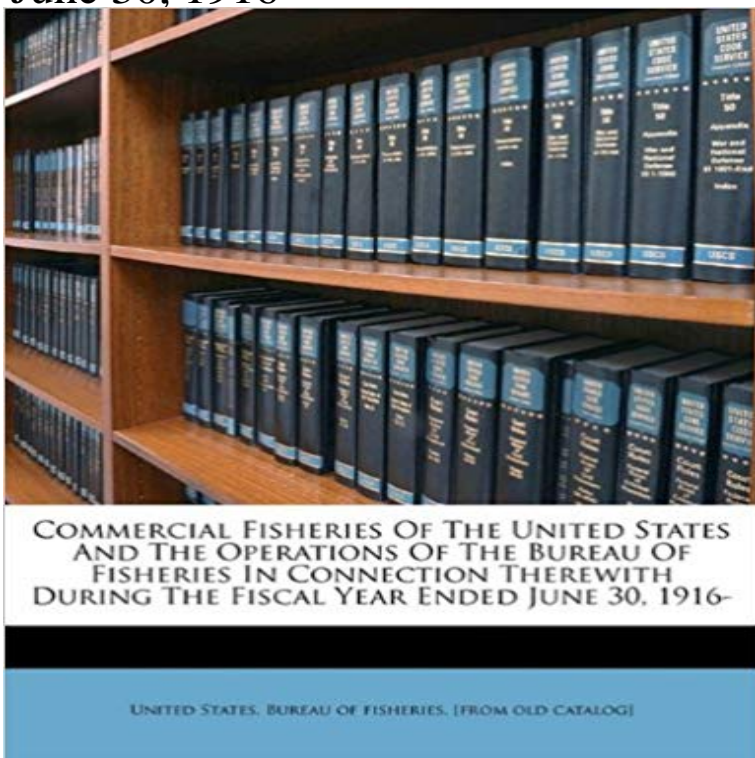


Commercial fisheries of the United States and the operations of the Bureau of fisheries in connection therewith during the fiscal year ended June 30, 1916-
